

U.S. Customs and Border Protection implemented the Importer Security Filing program better known as "ISF" or "10+2" to strengthen cargo security by making CBP (U.S. Customs and Border Protection) screening more efficient and effective. The fundamental purpose of "10+2" is to trace cargo from the actual manufacturer's facility into supply chains heading to the U.S.

## THE PROGRAM

The regulation requires importers to submit an "Importer Security Filing" (ISF) with the "10" additional shipment data elements listed below. Carriers will be required to submit the "2" additional items including: (1) a vessel stow plan used to transmit information about the physical location of cargo loaded aboard a vessel bound for the U.S; and (2) container status messages, which report container movements and changes in status (e.g., empty or full). The "10" items are:

- Manufacturer (or supplier) name and address
- Seller (or owner) name and address
- Buyer (or owner) name and address
- Ship-to name and address
- Container stuffing location
- Consolidator (stuffer) name and address
- Importer of record number/foreign trade zone applicant identification number
- Consignee number(s)
- Country of origin, and
- Commodity Harmonized Tariff Schedule number

U.S. Customs and Border Protection (CBP) published the final rule on 11/25/08 and it became effective on 1/26/09 (60 days after publication). The details of the rule are outlined here:



- The rule requires importers or agents to submit the ISF (Importer Security Filing) 24-hours before cargo is laden onboard vessel
- Flexibility is built into rule to allow for 8 of 10 data elements to be filed 24-hours before cargo laden on-board vessel:(Seller, Buyer, Importer of Record Number, Consignee Number, Manufacturer, Ship to Party, Country of Origin, Commodity HTS Number)
- Further flexibility to allow for the latter 4 elements to be updated with more precise/accurate information no later than 24-hours prior to ship arrival at USA port: (Manufacturer, Ship to Party, Country of Origin, HTS#)
- The remaining 2 data elements (container stuffing location and consolidator) should be submitted as early as possible, no later than 24-hours prior to ship arrival at US port

CBP is requiring that every importer be bonded; the following bond types are acceptable, and your specific bond number will be recorded as part of the "10+2" discussions you have with your SSR.

- Basic Importation and Entry Bond
- Basic Custodial Bond
- International Carrier Bond
- Foreign Trade Zone Operator Bond
- Importer Security Filing Bond
